BREAKING ALL RECORDS

Spirited Bidding For Lead and Zinc Ores—David Clark Uncovers a Body of Carbonate—Dividends From Fluor Spar—Paducah Happenings.

LAST WEEK'S SPLENDID RECORD!

The past week has been rather eventful in a mining way.

The year's work was rounded up by the stockholders of the Kentucky Fluor Spar company, and a generous dividend declared and paid. The annual meeting was held on Wednesday, and all of the capital stock was represented. There were present Mr. Thomas D. Jones, of Chicago, representing about one half of the stock, and Messrs. Maxwell, Blue, Nunn and Watkins, of Marion, owning the balance. Some transfers of the stock were made a few weeks ago, the price paid being \$135 per share, or \$35 premium.

It was anticipated that a 35 per cent. dividend would be declared on this, the first year of the existence of the consolidated companies. It was stated that but ten per cent. was declared, owing to the addition during the year of a very complete separating plant at the company's works in Marion, which probably cost very nearly the difference. The company's many mines are well provided with machinery and everything points to a still greater success for the ensuing year.

On the same day the first annual meeting of the Columbia Mining company was held in this city. Messrs. Porter, Johnson and Hudson, of Paris, Tenn.; Mr. Overby, of Paducah; Mr. Harry Watkins, of Marion, and one or two Northern holders of stock participated in the meeting. A visit was made to the Columbia mine, where the large separating plant is being constructed. The probabilities are that this mill will be in active operation within the next 40 days.

The highest price reported paid for zinc ore in the Joplin district last week was \$40 per ton, and the assay basis ranged from \$35 to \$37.50 per ton, according to the quality of the ore. A year ago the highest price was \$35 per ton. Some little competition was ushered into the lead market, and a few lots sold at a special price; lead sold generally at \$54 per ton, but there were a few instances where a higher price was paid, another buyer having dropped into the market who took several lots at an advance. A year ago the price of lead was \$45 a ton.

The total zinc sales, 4491 tons was perhaps about the equal of the output, though some of the buyers are of the opinion that the reserve is a little higher than a week ago. If there is any unsold ore in the district it is hard to find.

The district value of the output during the past week was \$103,291.

The Henderson Syndicate, Messrs. David Clark, Charles Dalm and Louis Baldauf, have uncovered a splendid quality of carbonate of zinc on their Farmer property adjoining Blue & Nunn's "Old Jim" mine.

For nearly two years Mr. Clark has given more or less of his time

to prospecting this land, as well as considerable of a tract of land known as the Thomas farm, both of which are owned by these gentlemen.

Last fall two trenches were cut, and a space left untouched a few feet in extent between them. Over this one of the members of the United States Geological Survey made the statement that there was no use prospecting for carbonate there. At a depth of about fifteen inches underneath where he then stood the vein of carbonate was uncovered on last Thursday. The ore is of a fine quality and there seems to be a large body of it.

The persistently progressive, pushing city of Paducah is not quite 42 miles from Marion. Its growth is simply wonderful. The older inhabitants can not yet reconcile themselves to the fact of meeting so many strange faces every time they happen to be on the street. The commercial club of Paducah, composed as it is of the younger business men of the city, are always ready to extend a helping hand to any enterprise that promises results. If one has a good thing they will surely push it along. Already some 51 factories of various kinds are giving employment to as many hundred operatives. Indeed the Paducahians, one and all, are disposed in every way to advance the interests of their city.

The combination of the Porter-Hudson Tobacco company, of Paris, Tenn., with the Smith-Scott works at Paducah is already showing the work of a strong man at its head. Mr. Porter, who was for several years in the fluor spar business in Marion, is the general manager of the combined company. The other day in Paducah he was loaning out the surplus funds of the company and the amount would have purchased a big slice of the city 25 years ago.

Other Marion people who are interested in Paducah have also had a mighty level head looking after their interests. Mr. P. S. Maxwell has recently leased to a syndicate of Paducah capitalists a tract of ground adjoining the Palmer House on Broadway, the lease being for 60 years, with an annual rental that would make any one except Marion mining men rich.

The genial cashier of the Globe Trust Co., Mr. H. H. Loving, a long time resident of Marion, is always called upon by our people when in Paducah, and from the crowd in his bank pretty nearly everybody else calls there some time during the day.

The exhibit of ores from Marion at the Palmer House by the Reed Mining company, created a great deal of interest and quite a number of lots, with the 1,000 shares of stock added, were sold. Mr. Roberts was assisted part of the time by that silver tongued, persuasive gentleman of Marion, Mr. James Henry, and both did their best to give the citizens

some idea of the "Mining Wonderland" here in Crittenden county.

All in all, social, financial, and every other way, we raise our hats to the people of Paducah.

There seems to be a deadlock between the Kewanee Fire Clay people and the teamsters in and around the Stevens farm, where this fire clay is being mined. The difference of 25 cents per ton has put a stop to the enterprise, for the present, at least. The company offer \$1.75 per ton to Marion; \$2.00 per ton is demanded by the men owning the teams.

It looks somewhat like a shortsighted policy on the part of the latter, inasmuch as the development of this section of the county not only enhances the value of all lands in the vicinity, but enables a contemplated railroad an opportunity to base the tonnage of freight it would reasonably secure from that point.

It is said that one hundred teams could be actively employed in the transportation of this clay for shipment to the works at Kewanee, from the Illinois Central at Marion. The farmers and land owners are most decidedly interested in having such an enterprise in their midst, and it would seem advisable that both sides should, if necessary, yield somewhat on this very slight difference.

Mr. Allie Moore, one of our legal gentlemen, was never accused of farming for either exercise or profit, but he has a little son who, during the past season, has attended to a plot of ground possibly one-sixteenth of an acre, covered with strawberry plants. This young gentleman has sold from this ground 247 gallons of strawberries at 40 cents per gallon and the field looks as though it would yield as many more; and this, too, in addition to the home consumption; and any one that knows Allie Moore's capacity for strawberries can figure out what the yield must have been. There is no question but that fruit culture of nearly all kinds in this section would return a splendid profit. Our sandy knolls, planted with a good variety of either apple or pear trees would return more money than the land owner would know what to do with. A good winter apple is always salable in any market at a good round price. Form a fruit culture club get the best information possible and raise fruit.

McConnelly & Keen, who are prospecting within ten miles of Elizabethtown, Ill., have uncovered what is stated to be the largest and strongest body of lead ore yet found across the river. The vein is nearly solid galena, six feet in width. Fred Clement, of Marion, who had just arrived from the shaft, telephones that the entire vein will average 60 per cent. of lead. The Marion Mineral company has a piece of property adjoining this land. It is about two miles from this company's great fluor spar property on the Lee farm.

Major Clement resumed work on the Clement mine last Monday.

It is somewhat strange that the miners in this section hesitate to contract by the foot for sinking shafts. Here is a gentleman who would much prefer to make a contract for a certain depth on a splendid mineral showing, and he does it to avoid the trouble and annoyance of personal superintendence. Have we a progressive man in camp who will take up such contracts and complete them.

The Seacoast Mineral company is having the usual rugged road to travel upon that most innovations do have. Possibly the placing in Paducah of a very costly method of separating our ores was a mistake, inasmuch as their value in the rough for such of our ores as require concentration is not large. Deducting freight from the mine to the plant at Paducah—a very good profit in itself—and add to that the cost of handling and re-shipping, the balance left is too small to afford the miner but little, if anything.

Of course the cure for this sort of thing is to place such plants in the immediate vicinity of the mines where the ore will meet the machinery for its dressing as soon as mined, and no unnecessary expense will be incurred.

It is expected that the Eastern end of the string will succeed in placing the company in bankruptcy, after which a reorganization will take place and probably the machinery will be taken to the ore fields of Western Kentucky where it naturally belongs.

Messrs. Black, Barnard, Little and McClelland, all of whom are interested in the Southern Illinois mining district, were in Paducah last week. The opinion of these gentlemen as to that field was very flattering; deep shafts are being sunk in many places, old abandoned properties are being resurrected and placed in productive shape and a general good feeling of prosperity but a little ahead of them was manifest in their conversation. Mr. Merritt, of Salem, was also in that city on Monday, en route for St. Louis, where he will remain a few days.

The Babb mining shaft, being one of the first openings made by Messrs. Blue & Nunn in the district, has a very large vein of disseminated zinc ore, something similar to the Joplin ground.

It is situated very near the Illinois Central railroad, and with the ordinary Joplin jigs for cleaning the Jack from the gangue it seems to offer very strong possibilities for mining and shipping ore. The Press understands that a lease can be made of this ground, and that but little capital would be required to make a handsome property out of it.

The lease on the property in Mexico, known as the Myers farm, some eight miles south of Marion, and on which extensive bodies of barites and fluor spar have been located, was sold last week to the Commercial Mining company, of Hopkinsville, for \$2,000 in cash and \$3,000 in the stock of the company. The property was originally leased from Mr. Myers by Jas. Henry and Lawrence Cruce, who afterward sold their interests to Kevel, Jameson & Fowler, of Marion.

The Rosi Claire vein, passing through the Babb farm, near Carraville, has been tapped by the Ohio Valley Mining company of Marion, and the showing in lead and zinc ores, as well as fluorspar, is unmistakably strong. Considerable excitement exists in that locality over this fact and extensive preparations are being made by the company to develop the property to its fullest extent.

He will shortly take up the study of analytical chemistry as applied to our ores, here for the purpose of checking the mill work at the Columbia mine. This mill will be in operation in about 40 days, and a very large output of both lead and zinc will be made.

Mr. J. A. Pierce, of Salem, has uncovered within a few miles of that city a body of carbonate 16 feet in width, of a first-class quality. On the same land and parallel to this vein of carbonate, is a vein of lead ore and white fluor spar eight feet in width. The samples shown in Marion by Mr. Pierce are number one in every respect.

President J. L. Frankel, of the Tradewater Coal company, of Sturgis, announces many improvements and a steady run of work for the new colliery, which is one of the most prosperous in the state. About one hundred new houses will also be built to accommodate the increased force of miners.

The shaft of the Wilson Mining company, near Crittenden Springs is now down 60 feet. It was not expected to reach the strike of the ore body at less than 75 feet, but from the assays constantly being made as depth is gained, the showing of zinc values indicates an ore body not far from the present depth.

The Crittenden Springs Hotel register showed a very large arrival list at that famous summer resort, Sunday last. Fully twenty ladies and gentlemen from various sections of the United States, reached the hotel that morning. Major Ira Pierce did the honors in his usual affable style.

Mr. George P. Roberts, for several years in the Washington and British Columbia mining country, reached here from Seattle last week. He will, after visiting the various mines, and familiarizing himself with the makeup of the district, commence work on the Reed Mining company's land.

King Alexander and Queen Draga of Servia Murdered By Revolutionists Friday Morning.

DEED APPARENTLY APPROVED BY PEOPLE.

A military conspiracy has resulted in the blotting out of the Obrenovitch dynasty of the kingdom of Servia, and the proclaiming of a new ruler. King Alexander and Queen Draga, the Queen's two brothers, Premier Markovitch, the Minister of War, two royal aids, and two other officers are known to have been killed. The King and Queen were assassinated 2 o'clock in the morning in the royal palace, which the soldiers forcibly entered. A new Cabinet was formed after the assassination and Prince Peter Karageorgewitch, pretender to the throne, was proclaimed King. It is stated that the new ministers of Justice and Finance planned the revolution. Advice in relating the details of the crime, say that the King and Queen were chased to the palace roof and there murdered by the soldiers. The Queen's two brothers were shot at their homes. Prince Karageorgewitch, the new King, is 53 years old and has three children. He has lived at Geneva since 1891, and though he declares his innocence of any knowledge of the assassinations, the revolution is believed to have been hatched in the Swiss city.

The revolution was executed without any opposition on the part of the people of Belgrade, and the capital and the country remain tranquil.

The assassination of King Alexander and Queen Draga, with the Prince Nicodan, heir to the Servian throne, thus bringing to a close the Obrenovitch dynasty, was the culmination of a long period of misrule by the half-crazed royal family. The scandalous conduct of Queen Draga, which has been the talk of European courts for years, with the weakness of the King, affords the most forcible illustration on record of Prof. Lombroso's somewhat sensational theory that all the royal families of Europe are by heritage moral degenerates. The extravagant conduct of the Servian ruling family is given in the most natural and almost logical solution of the outbreak which finally resulted in their murder in the palace, together with others identified with the administration of the government.

The newspapers are almost unanimous in approving the revolution. Some compassion is felt for the unfortunate King, but the people generally admit that no other solution to an intolerant situation was possible.

Prince Karageorgewitch declares himself innocent of any knowledge of the tragedy at Belgrade. He said that through his grandfather he undoubtedly had the best right to the Servian throne and intended taking it if possible for the sake of his son, but he expected to meet with great difficulties and hoped for assistance from Austria.

Leading Servian statesmen were long of the opinion that a general uprising was imminent the King's arbitrary rule, his persecution of all persons opposed to Draga and her family, financial depression and the instability of things generally tending that way.

It was openly charged that the King and Queen were jointly responsible for the attempt on the life of the late King Milan; that, indeed, they hired the murderers sent to assassinate their father and

father-in-law. The plotters could never have gone to work as they did if it had not been for the protection of the King and his concurrence, and that those caught red-handed were afterward suffocated in prison or tortured to death seems to indicate that Alexander feared their testimony. Among the conspirators foully murdered in their cells were Zivko Angelovitch, Governor of Shabatz, and another high official named Knezvitch, both of whom used to belong to Alexander's circle of intimates.

Almost without a murmur the Servian people have accepted the assassination of King Alexander and Queen Draga and the proclamation of a new ruler. Later reports about the bloody hour in the palace vary in detail from the first description of the assassination. There were ninety active participants in the tragedy. They fought their way to the inner chambers, when the palace lights went out and candles were resorted to by the soldiers. The King and Queen fled to a secret chamber, which was located by one of the Queen's servants. The royal pair were slain without parley.

MUST PAY A LICENSE

Hunting in Illinois is now a licensed sport. All Kentucky sport men, who desire to indulge in the pleasure of the chase in the woods and fields across the Ohio, must first equip themselves with a license. According to the game law passed by the last legislature, of Illinois, residents of the state can get this license for \$1 while the fee for non-residents is \$15.

For the \$1 fee each hunter living in Illinois gets a neat little blue linen backed document which he can tuck into his pocket. On the face of the license his name, occupation and description of person appears. The law requires that the holder produce it at the request of any game warden in the state. Punishment, either by fine or imprisonment or both, is provided for violation of the license provisions.

The only exemption made by the law is in the case of a land owner who hunts on his own land. A farmer may hunt on his own farm, but if he wants to cross over to his neighbor's he must equip himself with a license or run the risk of being caught and heavily fined.

County clerks will issue the license.

Thompson assumed the chair, took up the over-crowded program with amateur skill eliminated the subjects of the absent members. There ran through the exercise of the day a vein of characteristic humor of the speakers. The excellent music rendered alternately by the Sugar Grove, Crooked Creek and Hurricane choirs was one of the charming features of the occasion.

The first address was delivered by State Field Worker, Rev. Gebauer, on the subject, "Lesson Preparation." This was very impressively done, the speaker emphasizing the importance of preparation; the helps used, what, when and how to study. The next speaker was Rev. Flynn on the subject: "What Can We Do?" He briefly reviewed to the past work of the county and in his eloquent appeal for the need of more evangelical work, showed how one man could devote all his time to the Sunday school work of the county by the small donations of 25 cents from each church member.

The reports of secretaries were called for but owing to the limited time, all were not read.

Rev. J. F. Price in a very pleasant way proceeded to raise the amount necessary to pay the county apportionment to the State Association and incidental expenses. A number of schools responded by cash and pledges. Sugar Grove Sunday school leading with a cash contribution of \$7.90. A number of individuals contributed \$1 each. Twenty-eight subscriptions were received for the reporter. The total amount of pledges and cash, \$60. When all pledges are collected the county indebtedness can be paid in full.

The appointment of committees was next made and the convention took recess until 1:30.

The noon hour was greatly enjoyed by all, with so many good things to eat, covering hill, dale and jutting cliffs. Everybody obeyed the first impulse and became a participant in the bounteous supply.

The afternoon exercise began with song and praise service, conducted in a very inspiring and impressive way by Rev. W. T. Oakley. The first speaker was Rev. J. F. Price, his topic being a "Round Table on S. S. Management." Bro Price remarked that all had just enjoyed a "round table," and were not capacitated for another, especially of his "setting," so they would pass to the next

Several stolen suit cases and hunting coats have been found in pawn shops. A valise with Judge Rufus B. Smith's name upon it, was among them.

Nesbitt, the police believe, is a crook who has been operating in Cincinnati for some time. He says that he came to Cincinnati from Sturgis, Ky., just two weeks ago, and admits that he has been making his living by burglarizing Patton's place.

Detective Honillion knows of another man, who, with Nesbitt, burglarized the same place last Tuesday night. Nesbitt says he was led into the job by the other man. He has wealthy relatives in Kentucky, but says both of his parents are dead.

A dispatch from Sturgis in regard to the above says: The Cincinnati Post or the culprit is in error as to his place of residence. He never lived here and is known to but few citizens. However, he was at one time a close neighbor, having been reared in Crittenden by respectable parents, and being a nephew of a leading farmer of that section, Mr. Finis Black. Despite his early training and respectable connections he is reported to have been rather tough for one of his tender years before branching out as a "professional." He has two older brothers, Virge and Claud, who were soldiers in the Philippines. If Nesbitt was here only two weeks ago, as reported saying, no one in town remembers having seen him.

The young man who would fit himself for real influence in the forum must himself feel deeply upon the subject which he discusses, and he cannot feel deeply without being in full sympathy with those whom he addresses. He must be able to give them information which they do not possess, or to state what they know more forcibly than they can state it themselves.—The Commoner.

So Testified Capt. Ewen at Jackson Yesterday.

Jackson, Ky., June 10.—Capt. Ewen was the first witness for the prosecution in the Marcum murder case. He was placed on the stand at 11 o'clock this morning. He testified, in substance, on being examined by Mr. Byrd:

"I was standing beside Marcum in the front door of the court house: I was on his right side. Tom White passed by close to Marcum and looked him in the face. White went out and down about six steps and still looked at Marcum. Marcum's arm was on my shoulder. Marcum said: 'Ewing, I am afraid of that fellow. He is a bad man.' Just then a pistol shot rang out close behind us. Marcum's hand dropped off my shoulder and he fell backwards. He uttered a cry of pain. I whirled my head and saw Curt Jett coming with a pistol in both hands I ran, thinking he was going to shoot me. I then saw a motion in the side court house door. A man peered out. He stepped out and I saw it was Curt Jett. He walked out towards the well. He had his hands behind him and his hat was pulled over his eyes.

"I helped carry Marcum across the street to Dr. Kash's office, where he died a few minutes later. Fifteen minutes after the shooting I saw White and Jett walking a hundred feet away. I was well acquainted with Jett and saw him often. After the killing Jett was pale and kept his face toward the ground. Marcum's face was powder burned from the second shot, which went through his skull."

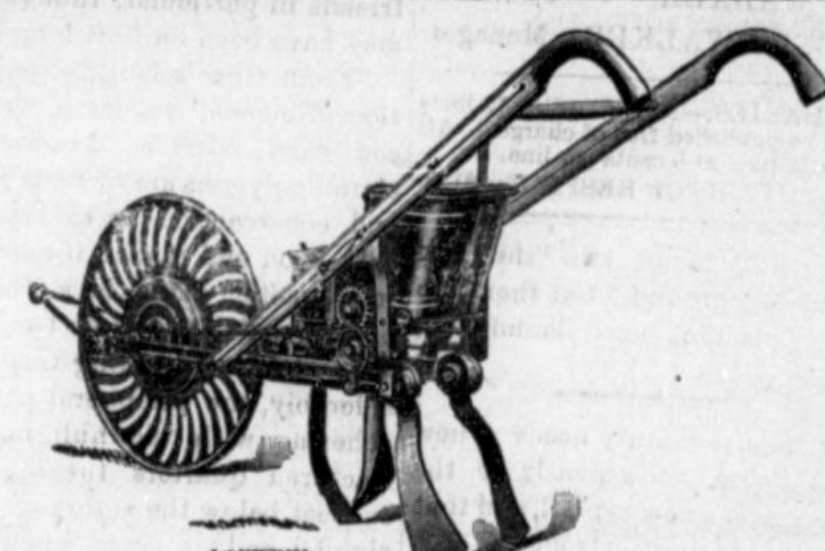

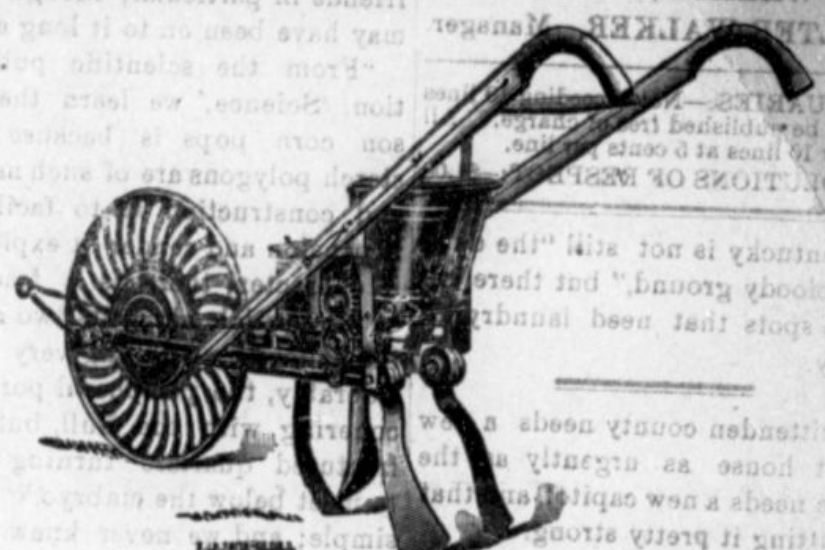

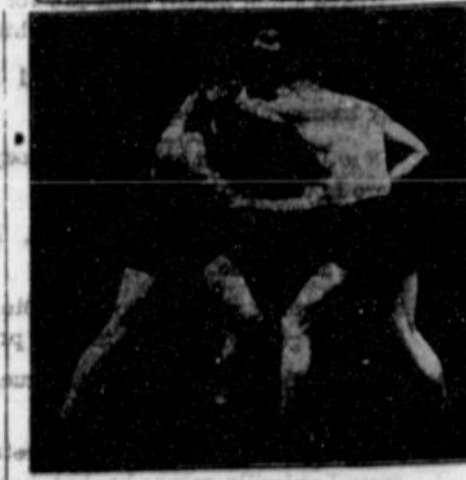

DON'TS FOR THE EYES.

Don't use the eyes when they are tired or weak from illness. Don't bathe eyes that are inflamed with cold water; use warm water. Don't wear a veil with black dots or one woven with double thread. Don't open the eyes under water when bathing, especially salt water. Don't neglect to bathe the eyes occasionally in salt water. A weak solution is best. Don't look too steadily from a car window at objects that are constantly flying past you. Don't sleep opposite a window or where a strong light will strike the eyes on awakening. Don't work longer than two hours without closing the eyes and resting for five minutes. Don't expose the eyes at any time to a strong light such as sun light, or gas, or lamplight. Don't sit facing a strong light. If possible let the light fall on the work or book from over the shoulder. Don't have colored shades on the lamps. Use white or ground glass. If you must have a colored shade, let it be green. Don't rub the eyes by outward motion, but toward the nose, as this rounds the ball and preserves the normal shape.

GREAT HOARD OF GOLD.

Nearly one thousand three hundred tons of gold lie today in the vaults of the Treasury of the United States, the greatest hoard of the yellow metal ever gathered in the history of the world. Four hundred tons of this gold are piled, like bags of salt, within the four walls of the Subtreasury in Wall street, New York. Outside the Treasury hoard there is in circulation throughout the country a nearly equal amount of gold coins, making more than two thousand five hundred tons of gold in the United States bearing the imprint of the eagle. The value of this coin is more than \$1,260,000,000.

A PICTURE GAME.

See That Will Result in Plenty of Fun and Laughter.

Here is a splendid game to introduce when you have a party of girls and boys with you at your house for an evening's good time. It is called the picture game. Those engaged in it sit around a table, and each player is supplied with a piece of writing paper folded into three parts and a lead pencil. Each one sketches a head and neck of a person or animal, taking care that his neighbor does not see his work. Then each refolds the paper so as to hide his or her sketch, but leaves indications of where the body is to be joined to the neck. The papers then change hands all around, and each proceeds to sketch a body for the head he has not seen. This accomplished, the papers are folded as before. Another change takes place, and all proceed to supply the nether limbs to the unseen bodies just as previously when supplying bodies for the invisible heads. When all this is done, another change of papers takes place, and each writes a name of the supposed animal or person above it. When the papers are unfolded, shouts of laughter at the absurd combinations in the pictures or the addresses given them are usually heard.

This game may be varied in a poetical way thus: The first one to write a line, fold the paper and give the last word of the line to his neighbor as the paper is passed. The next one writes a line, the last word to rhyme with the one before it, and so on till the paper has passed around the table. An easy word to rhyme, like sea, makes it more interesting.

A Game With Figures.

An interesting game by which a boy or girl may while away many a pleasant hour is the following: It is played with an antagonist, each in turn placing a number on paper from one to six, adding them up mentally as they proceed. The person who succeeds in placing the last figure which shall make the column add up 30 wins the game.

The player unacquainted with the secret always loses. The explanation involves the number 9. Your friend has written, say, 6. You put down, say, 3, which will add up 9. Your friend puts down, say, 1. You put down 6, for the second addition must equal 9. Again he puts down, say, 5. You make it 7 by adding 2. He puts down, say, 3. You again make it 9 by putting 6. The addition foots 9, and as you have put down the last figure you have won. Be careful to make the first addition 9 and the following three 9 each, and victory will never desert you.

The Why Giraffe.

Perhaps the most difficult of all wild animals to capture is the giraffe. In addition to being very rare, giraffes are exceedingly timid and are very swift footed. There is no special way to capture a giraffe, as almost every way has been tried, and all have been almost equally unsuccessful. The method which has occasionally resulted in a capture is by using a long cord, at each end of which is a round weight. This cord is thrown by the hunter in such a manner as to wind round the animal's legs, either bringing it to ground or rendering it incapable of escaping before it is made a prisoner. Most of the giraffes in captivity have been caught by chance when young.

FOR YOUNG FOLKS

A PICTURE GAME.

One That Will Result in Plenty of Fun and Laughter.

Here is a splendid game to introduce when you have a party of girls and boys with you at your house for an evening's good time. It is called the picture game. Those engaged in it sit around a table, and each player is supplied with a piece of writing paper folded into three parts and a lead pencil. Each one sketches a head and neck of a person or animal, taking care that his neighbor does not see his work. Then each refolds the paper so as to hide his or her sketch, but leaves indications of where the body is to be joined to the neck. The papers then change hands all around, and each proceeds to sketch a body for the head he has not seen. This accomplished, the papers are folded as before. Another change takes place, and all proceed to supply the missing limbs to the missing bodies just as previously when supplying bodies for the invisible heads. When all this is done, another change of papers takes place, and each writes a name of the supposed animal or person above it. When the papers are unfolded, shows of a light at the absurd combinations in the pictures or the addresses given them are usually heard.

This game may be varied in a poetical way thus: The first one to write a line, fold the paper and give the last word of the line to his neighbor as the paper is passed. The next one writes a line, the last word to rhyme with the one before it, and so on till the paper has passed around the table. An easy word to rhyme, like sea, makes it more interesting.

A Game With Figures.

An interesting game by which a boy or girl may while away many a pleasant hour is the following: It is played with an antagonist, each in turn placing a number on paper from one to six, adding them up mentally as they proceed. The person who succeeds in placing the last figure which shall make the column add up 30 wins the game.

The player unacquainted with the secret always loses. The explanation involves the number 9. Your friend has written, say, 6. You put down, say, 3, which will add up 9. Your friend puts down, say, 1. You put down 8, for the second addition must equal 9. Again he puts down, say, 5. You make it 4 by adding 2. He puts down, say, 3. You again make it 9 by putting 6. The addition foots 30, and as you have put down the last figure you have won. Be careful to make the first addition 9 and the following three 9 each, and victory will never desert you.

The Why Grabs.

Perhaps the most difficult of all wild animals to capture is the giraffe. In addition to being very rare, giraffes are exceedingly timid and are very swift footed. There is no special way to capture a giraffe, as almost every way has been tried, and all have been almost equally unsuccessful. The method which has occasionally resulted in a capture is by using a long cord, at each end of which is a round weight. This cord is thrown by the hunter in such a manner as to wind round the animal's legs, either bringing it to ground or rendering it incapable of escaping before it is made a prisoner. Most of the giraffes in captivity have been caught by chance when young.

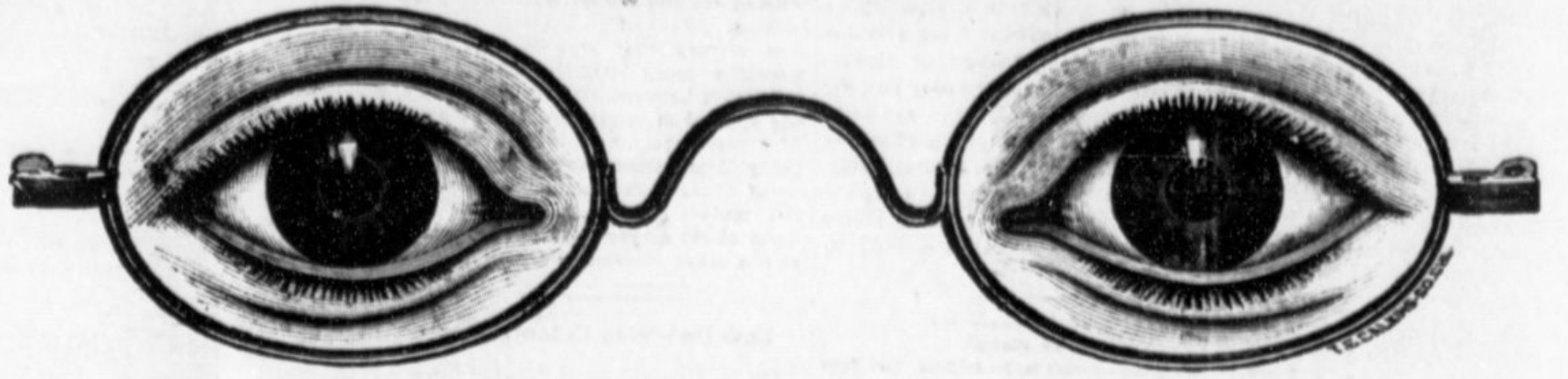

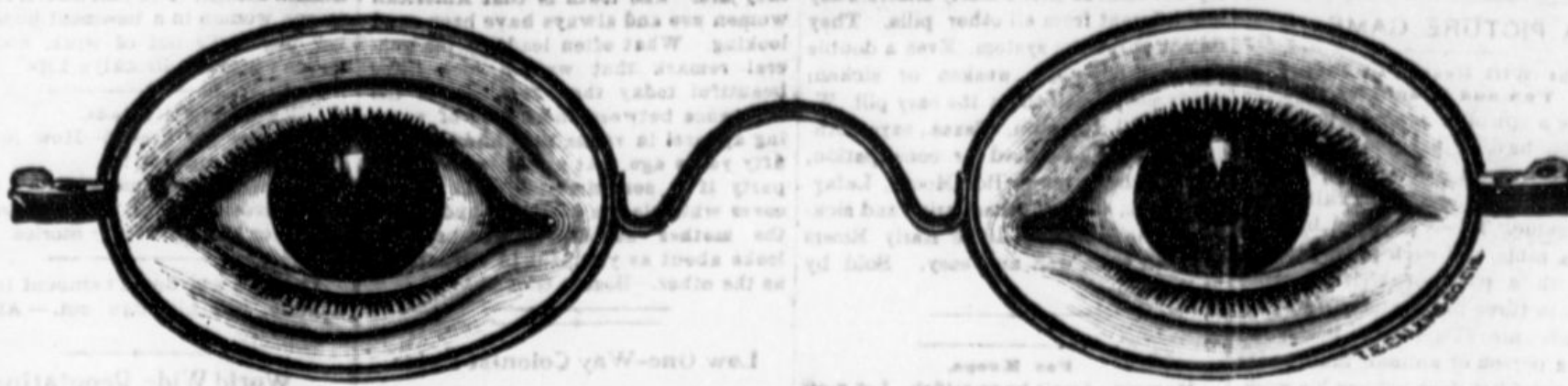
